## Motorcycle Rental Agreement

This agreement is made between **Leksol Automobiles** and **Mr. /Mrs.** \_\_\_\_\_, bearing **Passport/CID No.:** \_\_\_\_\_, for the rental of a motorcycle starting from \_\_\_ / \_\_\_ / \_\_\_\_\_ to \_\_\_ / \_\_\_ / \_\_\_\_\_, at the rate of **Nu.** \_\_\_\_\_ per day per motorcycle. The rental fee does not include fuel or insurance.

**Mr. /Mrs.** \_\_\_\_\_ shall be liable for all repairs or payments related to any accident or damage occurring during the rental period and agrees to the following terms:

1. Any parts or accessories damaged during the rental period must be replaced. **Repairs or modifications will not be accepted.**
  2. The client agrees to return the motorcycle in **clean, undamaged** condition and **with full tank fuel** to avoid additional charges for repairs, maintenance, or replacements.
  3. The client must return the motorcycle **before 6:00 PM** on the last day of the rental period. Failure to return the motorcycle on time will result in an additional charge equivalent to **one full day's rental rate.**
  4. Damaged parts or components will be repaired or replaced at the Service Centre's discretion. The client agrees to pay the Service Centre's regular rates and retail prices for any replaced components.
  5. The client has inspected the motorcycle, agrees that it is in good running condition, and will return it in the same condition.
  6. The client accepts the motorcycle and equipment in good condition and takes full responsibility for them during the rental period.
  7. If the client loses any documents, or if documents are seized by authorities during the rental period, the client agrees to bear all penalties and handle all follow-ups with the relevant authorities.
  8. The client will follow all traffic and relevant laws of the land. The company will not be responsible for any consequences arising from the client's non-compliance.
  9. The company will not be responsible for the client's health or any medical issues during the rental period.
  10. The company will provide a helmet, and the client must wear it at all times as required by law.
  11. The client agrees to pay 100% of the rental fee at the start of the rental period.
  12. The company has answered all inquiries raised by the client.
  13. The client has read and understood all the above provisions.

14. The client must not operate the motorcycle under the influence of alcohol or drugs.
  15. For cancellation we will be deducting the 50% of the rental amount.
